- 4b. RESOLUTION NO. 2018-0007/CASE NO. PLNG2018-0033DRB, A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF HAWAIIAN GARDENS, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, APPROVING A REQUEST TO APPROVE A CONDITIONAL USE PERMIT (CUP) SUBMITTED BY MANILAL PADHIAR TO REMODEL AN EXISTING RELIGIOUS ASSEMBLY FACILITY AND CONSTRUCT A NEW 1,411 SQ FT. PATIO COVER ON PROPERTY LOCATED AT 22110-16 PIONEER BLVD., HAWAIIAN GARDENS, CA 90716

Joseph Colombo, Community Development Director, addressed the Commission and indicated Contract Planner Manny Mancha would be presenting the staff report relative to both Case No. 2018-0001DRB and Case No. PLNG2018-0033CUP. Director Colombo indicated both items will be presented together but voted upon separately. Mr. Mancha presented staff report along with a power point presentation and indicated applicant is requesting approval to remodel an existing religious assembly facility and construct a new patio cover.

Some of the items discussed were the existing patio and if any citations were issued; the color scheme; the decorative windows and if any written communication from neighbors was received. Also it was briefly discussed that the front of building is facing the public works yard.

Mr. Manilal Padhiar, Vice President and coordinator for the temple, from Huntington Beach, stepped forward and indicated temple has been there for twenty-five years and they are looking forward to the new design. He indicated that the new design will be the first of its kind in the United States and members are very excited. He indicated that in the future they will be upgrading the restrooms to comply with handicap regulations and he will be in contact with the planning department. He has reviewed and accepts all the conditions.

Chairmember Schultze opened the public hearing and asked for all those wishing to speak in favor of or in opposition to, to step forward, state their name and address for the record and make their comments.

Mr. Darrel Patel, 12323 Essex Street, Cerritos CA, stepped forward and spoke in favor of the project and thanked the Planning Commission for their review of their proposed temple modifications and patio. He indicated all members present are here because they care deeply for the city.

Mr. Patel, 4822 El Rancho Verde, La Palma, CA, stepped forward and spoke in favor of the project thanked the City for allowing them to open their temple 25 years ago. They are surrounded by neighbors that have welcomed and embrace the temple. He has attended the temple for approximately ten years and they are very welcoming, very peaceful. He indicated he is looking forward to the end result of project.

Chairmember Schultze closed the public hearing.
