  - Pioneer Blvd. in front of the CRL Activity Center
  - 221<sup>st</sup> near Pioneer Blvd. in front of the Public Works secondary yard
  - 221st at Norwalk Blvd.

Staff informed the commission on the three new modifications received. First, red curb line on Pioneer in front of recreation building will be removed. Second, pertains to Public Works added red curbing to allow visibility when entering and exiting the secondary Public Works Yard. Third, on 221st at Norwalk, red curbing will be added to both sides of 221st.

5. QUARTERLY UPDATE ON PUBLIC WORKS ACTIVITIES

Public Works Executive Assistant informed the Commission that Republic would be processing outstanding and credit bills this month. Also, Commercial Waste has bulky item pickup once a week for apartment complexes and multi-family free of charge. Single home bulky items pickup would be once a month. Staff answered all the Commissions inquiries.

# **COMMISSIONER REPORTS**

Vice Chairmember Amaro commented he is glad to see that the City now has Public Safety Officers.

Commissioner Mendoza felt this year's Fourth of July was quieter and safer.

Commissioner Meraz compliments the new red curbs being added on 221st and Norwalk.

Commissioner Laughlin questioned if aerial fireworks after fourth of July could be called in to the Sheriff's Department? Sgt. Maese replied, yes. In addition, Commissioner Laughlin questioned the monetary fee for setting off illegal fireworks. Sgt. Maese replied, according to California Penal Code, it's \$1,000 dollars. Human Resources Manager, added that other fees may apply depending on where it is occurring depending on municipal codes adopted. Also, Commissioner Laughlin raised a concern regarding vehicles on 212th Street double parking during early evening hours during the week. Staff replied, to call the Safety Center to have PSO's attend to the matter or call the Sheriff's Department if it's late nights. Lastly, Commissioner Laughlin wanted to know if the City would partner with Lakewood Public Safety. Staff responded, that Staff does attend Public Safety Collaborative Groups and discuss different items. Individual City level, staff does communicate with City of Lakewood on specific issues. However, City of Lakewood is not as responsive as we would like them to be.

Chairmember Rico wanted to thank everyone. The City Manager is now bringing more resources and assets, it's just going to get better. It may take a little time, but we will get to where we need to be.
