- 6. Response to General Commission Inquiries:

Staff responded to previous Commission inquiries from last meeting. One of the concerns were the portal potties being too close to the food vendors. Staff addressed to the commission that the distance and space of the portal potties is a County of Public Health Department matter and a requirement. Suggestions will be forwarded to Special Events coordinator. Staff has also put in a request for missing street sign. The request to look at the red curbing in front of C. Robert Lee is still in the process. Google Map images have been requested to present the specific area to be looked at.

COMMISSIONER REPORTS

Commissioner Laughlin reported placing a call for service and officer who assisted her, took a long time before getting all the information necessary. Staff suggested requesting a follow up call or tag number.

Vice Chair reported a bus that was observed parking in Hawaiian Gardens with Cannabus logo on it. Vice Chair would like to know if it's possible to assign parking for charter buses who use the La Quinta Hotel. Also, on the corner of Carson and Hawaiian, there is a fence on that property that is in terrible conditions and is a safety concern. Lastly, Vice Chair Amaro requests that the City Attorney attend another commission meeting to discuss aggressive panhandling. Staff addressed the Cannabus and code enforcement has been sent out. La Quinta parking, that is something that can be looked into. On the issue of the fence, code enforcement has been sent out there. Last item, on panhandling, Staff can forward the panhandling concern to the City Manager.

Commissioner Mendoza has noticed an increase in shopping carts and in graffiti. Lastly, cars are still running the stop sign on Horst and 221st.

Commissioner Meraz- nothing to report.

Chairmember Rico agrees with Commissioner Mendoza in regards to the loud fireworks and individuals running the stop sign.

Staff responded to the commissioners concerns regarding individuals running the stop sign and will forward the concerns to motor patrol deputies to patrol.
