Second Item - Commissioner Amaro has brought up the area of Carson and Belshire as an area where people are parking too close to the corners. Ms. Suniga would like to note that Mr. Licon has given out more citations in this area. After the citations were issued, Ms. Suniga has driven by for a couple of days and noticed that cars were not parking there. In addition, Ms. Suniga would like to note that the city has increased the number of overall citations issued in an effort to improve conditions.
