Commissioner Amaro comments on Item B1 t June minutes stating he would like to have corrections made on the Commissioner Reports section E. He recalls stating bringing up an item "to discuss as a whole" and would like that phrase added to the minutes.

Commissioner Amaro pulled item B2 because Vice Chairmember Mendoza and Commissioner Rico were excused from last meeting, therefore, if they had any questions for SGT. Maese in regards to the report he could address them.

Vice Chairmember Mendoza has a question regarding the year to date crime rates. Her question is regarding the percentages on the 2017 crime rates. Staff and SGT, Maese explained the report.

Commissioner Amaro motioned to receive and file Item B2. Commissioner Mason 2nd. All in favor, motion passed.

C. STAFF REPORTS

D. DISCUSSION ITEMS

1. YAL Program Update

The city and the county have agreed to a shared cost. The city will be paying 25% of the personnel cost. The county will then cover the rest and continue servicing local. Our YAL will really cater to Hawaiian Gardens community without excluding other station areas. Deputy Ferreira has done a great job with identifying with the kids. The membership in the YAL has also grown. The current YAL room is going through some upgrades and renovations where they are modernizing the room. Commission were pleased to know the program was staying.

2. Community Services Coalition

Community Services Coalition is a newly formed coalition along the lines of the Homeless Coalition. It has been requested that a coalition focusing on gangs is created. What this coalition is, is stemmed from an effort to looking for other alternatives to gang membership. This coalition includes Ernie Vargas to talking to individuals who have been released from prison and providing options so that they do not return to that way of life. In addition, our church members will have a list of services and resources available when people seek help. This is not specifically for gang members. It is going to be for people having barriers with finding employment or returning to life in the community due to barriers with things from the past such as: incarceration, gang injunction, just getting

in trouble with the law and never really found a way out. There is a lot of re-entry programs, legal help, services that provide assistance with getting identifications, expunges to name a few. The Community Services Coalition's goal is to put everything together so we can educate and train those that service that population. We are also collaborating with SELACO which is a job placement organization. They run a gardening business and now have grown. They hire people who were formerly incarcerated or former gang members.

Special shoutout to Deputy Ferreira for helping with National Night Out. He makes the giant banner for the parade, he also provides the sound system and DJ. In addition, he will also bring his photo booth. This year we are having a block party. The street directly across the park will be closed on Clarkdale and 221st. Parade will start at 5:30pm.

Commissioner Amaro, called Republic Services to make an appointment for pick up, however, they failed to show up the first time. He had to call again and confirm for another appointment and they did pick up the second time. Commissioner Amaro would like to know if it could be a possibility that the city can send out a letter to residents informing them about Block Clean-Up. Staff informed commission that PW will be placing flyers in the area where the event will happen not only to inform them but also to remind them about parking restrictions. Also, Staff has had discussion with the Public Works Executive Assistant about possibly sending a cardstock flyer with all the Block Clean-Up events to city residents. Commissioner Amaro agrees with this option. Staff suggested making this a recommendation

E. COMMISSIONER REPORTS

Vice Chairmember Mendoza had a concern with a street light that has been out, wanted an update on the light. Public Works has sent another request for service to Edison. Also, for 4th of July was crazy, however, after 4th of July it has been quieter not like previous years.

Commissioner Rico attended the Car Show and he was impressed to see the Car Show is coming back.

Commissioner Amaro wanted to report a hole on the fence between the condominiums and the fire department. Deputy McCarty informed commission that the Los Angeles County Public Works has been notified and is fixing it. They have also given the encampment individuals a 2 week notice vacate the premises. Commissioner Amaro also reported a turned around Stop sign on 12252 224th St. South West corner. It appears as the stop sign has been removed from the concrete and turned around

Chairmember Meraz has a concern with the corner of Norwalk Blvd, and 215th on the Pescador corner. Her concern is that cars park right at the corner making it difficult for cars to come out. Chairmember Meraz wanted to possibly see if red curbs could be painted. Staff suggested to give this report to Parking Enforcement and have him survey the area first and then also give the recommendation for red curb to City Engineer.
