## D. DISCUSSION ITEMS

- 1. UPDATES ON ITEMS RAISED BY THE COMMISSION
  - Traffic Enforcement

The City has contracted with the Los Angeles County Sheriff's Department for a motorcycle Deputy to conduct traffic enforcement. The hours of traffic enforcement vary and citations have been issued, primarily for stop signs, traffic signal, and cell phones. The traffic enforcement is done throughout the city in areas of concern. City is going to continue with this enforcement until an evaluation can be made on the need and effectiveness.

Illegal Dumping & Bulky Item Pickup

The City is continuing to address the issue of illegal dumping. The most recent "Block Clean Up" in May was increased by three staff members to work the clean up in order to

allow the Public Works staff to make a sweep of the city of bulky items dumped and illegal dumping. The announcement of the "Block Clean Up" in the community seems to generate an excessive amount of items left out throughout the city.

Secondly, the City did meet with our disposal contactor Republic, to discussion the bulky dumping. They agreed that there is a problem and agreed to do a sweep of the City back in June. This entailed Republic doing a sweep of the entire City at no charge the day after regular trash pickup which generated 91 separate pickups. Republic will be purposing bulky item pickup service to present to the Interim City Manager for consideration.

- Lighting on Norwalk Blvd. (Agenda Item A1)
- Carson & Arline corner parking

Update on the Carson & Arline corner parking where the Casino buses parked and made it hard to make a right hand turn. This concern was passed onto the City Engineer so that he can make a recommendation and staff will keep the Commission updated on this item.

#### Fireworks

The illegal fireworks have been bought up to the attention of City Council by the city residents and staff. The City Council is committed in reviewing the issue of illegal fireworks.

Brief discussion on the fireworks was discussed among the Commissioners. There was a suggestion of the possibility of banning fireworks. It was also noted that Fresno County uses a device called "Shotspotter.com" to pin point where the shots and/or illegal fireworks are coming from. It was suggest that perhaps the City can consider this particular option.

#### UPCOMING EVENTS

National Night Out – August 2<sup>nd</sup>

The National Night Out will begin with a peace march starting from City Hall and ending at the Public Safety Center. The march will be led by the Los Angeles County Fire Department. There will be a safety fair at the Safety Center with various agencies, along with National Night Out t-shirts for all participants along with a complementary BBQ. National Night Out is celebrated throughout the County and promotes safety in our communities.

## E. COMMISSIONER REPORTS

Commissioner Rico expressed concern from resident who have informed him of gang members shooting out street lights along 226<sup>th</sup> Street. It was noted that Commissioner Rico did survey 226<sup>th</sup> Street and confirmed that the street was dark due to the shot out lights.

Staff informed the Commission that these can be referred over to the Public Works Department.

Vice Chairperson Mendoza addressed several concerns in one in regards to street sweeping (street sweeping, code enforcement, and public safety). On the day of street sweeping residents in the morning rush to move their parked vehicles out of the way to avoid getting tickets. This is done after the street sweeper has gone by, and leaving the

street un-swept. It has gotten to the point where residents run in front of the street sweeper creating a dangerous situation.

In other Cities one side of the street gets swept on Tuesday and the other side gets swept on Wednesday. The question asked was if the City has that capability.

Chairperson Mason wanted to thank law enforcement, Interim City Manager, and City Council of coming out to the Neighborhood Watch that was held at the Centralia Apartments.
