COMMON CODE ENFORCEMENT DIVISION ISSUES

The City of Hawaiian Gardens Code Enforcement Division responds to complaints from citizens, peer to peer groups, and other agencies regarding property maintenance issues. Systematic inspections are also performed throughout the City in an effort to keep developing situations from becoming worse. The City is currently aggressively pursuing illegal garage conversions due to the serious health and safety issues they present. An illegal garage conversion occurs when a property owner alters or modifies their garage for living purposes without obtaining the proper approvals or permits from the City.

When a garage is illegally converted into living quarters, serious health and safety issues are created. Improperly installed electrical wiring may cause fires, improper venting of water heaters or heaters may cause asphyxiation resulting in possible injury and/or death, and plumbing installed not according to the Building Code may lead to other health hazards. Other health and safety issues associated with illegal garage conversions may include not having the proper amount of emergency exits or windows, not having fire resistant construction materials, and insufficient fire prevention systems or smoke alarms.

In addition, illegal garage conversions affect the quality of life in your neighborhood. Improper and illegal occupancy of a converted garage increases the

overall density in the City, thus increasing demand for City services, and impacting on-street parking.

A garage is meant to store your vehicles and personal items, and not to serve as a living quarters. An illegal garage conversion may cost someone his or her life, and this is why the City regards the enforcement of illegal garage conversions as a priority. Please be aware that legal action may be taken against any property owner who rents out an illegal dwelling, which results in harm or injury to its occupants. Fines and permits to restore a garage conversion to its original use can cost a property owner more than \$750.00. In addition, Section 16.16 of the Hawaiian Gardens Municipal Code requires that a property owner whom evicts a tenant from an illegal dwelling is required to pay relocation benefits.

We encourage tenants and owners to take pride and responsibility in maintaining their properties, and it is the City's goal to achieve voluntary compliance.
